After the 30-day deadline, any cancellations, reductions in services, or no-shows will be charged to the card on file on the wedding day.

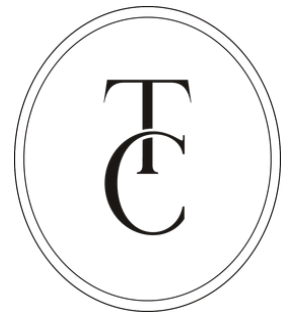
By signing below, I authorize Tailored + Co Salon & Med Spa to securely store the credit or debit card provided above.

Terms & Conditions



This Agreement ("Agreement") sets forth the terms and conditions between the bridal hairstylist (the "Stylist") and the client (the "Client") for wedding hairstyling services. By signing this Agreement, both parties acknowledge and agree to the terms outlined below.

1. Services

The Stylist agrees to perform bridal hairstyling services as detailed in the Client's booking. This may include consultations, trial sessions, and hairstyling on the wedding day. All services will be delivered in a professional and timely manner.

2. Payment

The Client agrees to pay the total service fee as outlined in the booking invoice. A valid credit or debit card is required to reserve the wedding date and will be securely stored on file. All bridal party services and final guest counts must be finalized no later than 30 days prior to the wedding date.

3. Cancellation and Refunds

The Client may make changes to the number of services up to 30 days prior to the wedding date. Once the wedding is within 30 days, all services and guest counts are considered final. Any cancellations, reductions in services, or no-shows after this deadline will be charged to the card on file on the wedding day.

Tailored + Co will make every effort to accommodate additional services requested after the 30-day deadline; however, availability cannot be guaranteed.

4. Travel Expenses

A travel fee of \$30 applies to all on-location services within Watertown, SD. For locations outside of Watertown, a travel fee of \$1 per mile from Tailored + Co Salon & Med Spa will be charged. Travel fees include one stylist. If additional stylists are required to accommodate the booking, an additional travel fee of \$50 per stylist will apply. For event locations more than 75 miles from Watertown, SD, the Client agrees to provide hotel accommodations for the stylist(s). For locations requiring air travel, the Client agrees to cover the cost of flights and hotel accommodations for the stylist(s). All travel-related fees and accommodations must be arranged and approved prior to the event date.

5. Schedule & Final Details

The Client agrees to provide a finalized wedding schedule, service selections, and bridal party guest count at least 30 days prior to the wedding date. Changes requested after this deadline may not be accommodated due to scheduling limitations.

6. Stylist Responsibilities

The Stylist agrees to: Arrive on time and fully prepared, perform services in a professional and sanitary manner, and use high-quality tools and products. In the rare case the Stylist is unable to fulfill their obligations, a refund or qualified replacement will be provided.

7. Client Responsibilities

The Client agrees to provide accurate, up-to-date information regarding the wedding timeline, location, and desired services. Clean, dry hair is preferred day of. There will be an additional fee if drying is required. Please come with a clean, moisturized face if makeup is desired. The Stylist is not responsible for delays or disruptions caused by inaccurate or incomplete information.

8. Use of Images for Marketing

The Client grants permission for the Stylist to use images or video of the completed hairstyling for promotional and portfolio use. If restrictions are desired, the Client must notify the Stylist in writing prior to the wedding day. The Stylist will make reasonable efforts to accommodate such requests.

9. Force Majeure

Neither party shall be liable for delays or failure to perform due to events beyond their control, including natural disasters, illness, acts of government, or other emergencies.

10. Governing Law

This Agreement is governed by and shall be interpreted under the laws of the State of South Dakota, United States of America.

Bridal Prep Tips

A little prep goes a long way. These tips will help you feel confident, radiant, and completely ready to enjoy every moment of your wedding morning.

Bridal Hair & Makeup Trial

For the best results, we recommend scheduling your hair and/or makeup trial about **1–3 months before your wedding day**. This timing allows your skin tone, hair length, and color to be close to how they'll be on the big day, while still leaving time for any refinements. To make the most of your trial, consider these tips:

- ***Wearing white.*** Opt for a light-colored or white top with a similar neckline to your wedding dress. This helps you better envision your full bridal look.
- ***Prep your hair.*** Arrive with clean, dry hair. Wash and blow-dry the night before using minimal product. Skip heat styling tools like flat irons or curling wands if you're doing a hair trial, our stylists will handle the styling. If you're only doing a makeup trial, lightly style or curl your hair so you can see a more complete preview of your wedding day look.
- ***Bring inspiration photos.*** Select 1–3 makeup or hair styles you're drawn to, ideally featuring clients with similar features or hair type. This gives us a clear vision to start from.
- ***Consider a spray tan.*** If you're planning a spray tan for your wedding, we recommend having a trial tan 2 days before your makeup trial. This helps ensure your makeup preview matches your wedding day glow.
- ***Bring your accessories.*** Bring along your veil, hairpins, jewelry, or any other accessories you plan to wear. We can experiment with placement and secure them perfectly for your final look.

Skincare

Healthy, glowing skin is the perfect canvas for your bridal makeup. Start a consistent skincare routine at least **6–12 months before your wedding** so your skin has time to adjust and thrive.

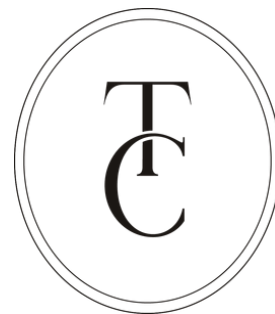
- Book regular facials every 4–6 weeks (DiamondGlow® is a favorite for brides!).
- Use at-home masks for hydration, brightening, and exfoliation.
- Drink plenty of water. It really makes a difference.

Spray Tanning

For an even, natural glow:

- Avoid tan lines leading up to the wedding (bathing suits, watches, sports bras).
- Schedule your spray tan 2 days before the wedding to allow color to settle beautifully.

Do you provide on-site services?

Yes! We offer on-location styling so you can relax and enjoy your morning. A travel fee of \$30 applies to all on-location services within Watertown, SD. For locations outside of Watertown, a travel fee of \$1 per mile from Tailored + Co Salon & Med Spa will be charged.

How many stylists will you bring on the wedding day?

It depends on your bridal party size and timing needs. For parties of 5 or more, additional stylists are often brought in to keep things running smoothly and on schedule.

What products do you use?

We use only professional-grade products selected for their performance and longevity—perfect for all-day wear and high-definition photography.

What if I or a bridal party member has allergies or sensitivities?

Please let us know during booking or your trial so we can plan accordingly. We have hypoallergenic and sensitive-skin options available.

Do you provide hair extensions or placement services?

Yes! If you're wearing extensions, please bring them to your trial. We can also help with proper placement on the wedding day.

What if someone in my bridal party needs to cancel or wants to add a service?

We'll always do our best to accommodate additional services based on our schedule and stylist availability. All services and final guest counts must be finalized no later than 30 days before your wedding. After that deadline, any cancellations, reductions in services, or no-shows will be charged to the card on file.
