

Photography Session Agreement

By booking a photography session with Marcie Reif Photography (MRP), you agree to the following policies:

Payment & Booking

Your session date and time are not reserved until your session has been **paid in full**.

All session payments are **non-refundable**. By booking, you are reserving a specific date and time on MRP's calendar.

Cancellations & Rescheduling

If you need to cancel or reschedule your session, we kindly request **at least 72 hours' notice whenever possible**.

We understand that unexpected situations can arise, and we will do our best to work with you when they do.

Rescheduled sessions must take place within **6 months of the original session date**. After 6 months, all payments made will be forfeited and a new session will need to be booked.

Rescheduling is subject to Marcie Reif Photography's availability, and a specific replacement date or time cannot be guaranteed. All session payments remain non-refundable.

Sickness

If you or someone participating in your session is sick, please contact Marcie Reif Photography as soon as possible.

We would much rather reschedule than photograph someone who is sick, particularly when working with newborns, young children, and families. We will work with you to find another available session date.

Late Arrivals

Please arrive on time and ready for your session. If you arrive late, your session may need to be shortened depending on MRP's schedule, available light, studio availability, or other circumstances.

Additional time or a replacement session is not guaranteed due to a late arrival.

Weather

For outdoor sessions, Marcie Reif Photography will monitor the weather and make the final decision if conditions require the session to be rescheduled.

If MRP determines that weather conditions are not appropriate for your session, we will work together to find another available date and time.

If you choose to cancel or reschedule because of predicted or impending weather **before MRP has made the decision to reschedule**, that is considered a client-requested reschedule and is subject to the regular rescheduling policy.

Photographer Cancellation or Emergency

In the event that Marcie Reif Photography is unable to photograph your session due to illness, injury, family emergency, severe weather, or circumstances beyond our control, we will make every reasonable effort to reschedule your session.

If MRP is unable to provide or reschedule your session, all payments made for the session will be refunded. This refund will be the extent of MRP's financial responsibility.

Artistic Style & Session Expectations

By booking your session, you acknowledge that you have reviewed and accept the photography and editing style of Marcie Reif Photography.

MRP will use professional judgment regarding posing, lighting, locations, composition, image selection, and editing. While we are happy to hear about images or combinations that are important to you, **specific poses, photographs, expressions, or results cannot be guaranteed.**

Marcie Reif Photography cannot guarantee the cooperation, behavior, or expressions of children or other participants. Sessions will not be refunded or repeated due to a participant's unwillingness or inability to participate.

Gallery & Image Delivery

You will receive an online gallery containing the **best edited digital images from your session**. Your finished digital images may be downloaded directly from your gallery.

Your gallery will be delivered within **14 business days of your session**, unless otherwise communicated.

The number of images delivered may vary depending on the type and length of the session, number of participants, and circumstances of the session.

Additional Retouching

Standard professional editing is included with your finished images.

Requests for extensive retouching or image manipulation beyond MRP's normal editing process may not always be possible and may require an additional fee.

Pets

Dogs and other pets are **not permitted in the studio**.

Pets may be included at outdoor locations **with prior permission from Marcie Reif Photography and when permitted by the location**.

All pets must remain **on a leash at all times, no exceptions**. The client is responsible for their pet's behavior and safety throughout the session.

Publicity & Promotional Use

By signing this agreement, you grant Marcie Reif Photography permission to use images from your session for portfolio, website, social media, advertising, editorial, competition, publication, and other promotional purposes.

Copyright & Client Image Use

Marcie Reif Photography retains the copyright to all photographs created during the session.

The digital images delivered in your gallery are provided for your personal use. You may download, print, and share your images.

Images may not be sold or used for another business or commercial purpose without written permission from Marcie Reif Photography.

Safety & Client Responsibility

The client is responsible for themselves, their children, pets, and other participants during the session.

Clients are responsible for following any rules or restrictions associated with the studio, property, venue, or location where the session takes place.

MRP reserves the right to stop or modify any activity that the photographer believes could create an unsafe situation.

Liability

Marcie Reif Photography will take reasonable care while providing photography services.

To the extent permitted by law, MRP's financial liability arising from the session or this agreement will not exceed the total amount paid by the client for the session. MRP will not be responsible for indirect or consequential losses arising from the session.

Entire Agreement

This agreement represents the understanding between Marcie Reif Photography and the client regarding the photography services being provided.

Any changes to this agreement must be agreed upon in writing by both the client and Marcie Reif Photography.

This agreement will be governed by the laws of the State of Georgia.
