Personal Information You Provide Directly

When you contact us, submit a booking form, or inquire about services, you may provide:

- Your name
- Phone number and/or email address
- Home address (for in-home pet sitting & dog walking services)
- Information about your pet(s), including species, breed, age, health history, and behavioral notes
- Emergency contact information
- Veterinarian contact information

Information Collected Automatically

When you visit our website, certain information may be collected automatically by our website hosting platform, including:

- Your IP address and browser type
- Pages viewed and time spent on our site
- Referring website or source

This data is collected in aggregate and is not linked to your personal identity. It is used solely to understand general website traffic and improve our online presence.

3. How We Use Your Information

We use the information we collect for the following purposes:

- To respond to your inquiries and booking requests
- To schedule and provide pet sitting and dog walking services
- To contact you about your booking, upcoming visits, or changes to service
- To maintain records of your pet's care needs and history
- To send service-related communications (e.g., booking confirmations, invoices)
- To improve our website and the quality of our services

We do not use your personal information for targeted advertising, nor do we sell, rent, or trade your information to any third party for marketing purposes.

4. How We Share Your Information

We do not sell or share your personal information with third parties, except in the following limited circumstances:

Service Providers

We may use trusted third-party platforms to operate our website or manage communications (for example, our website host or booking form provider). These platforms may have access to your information only to the extent necessary to perform their functions and are required to keep your information confidential.

Legal Requirements

We may disclose your information if required to do so by law or in response to a valid legal request, such as a subpoena or court order.

Emergency Situations

In the event of a veterinary or other emergency involving your pet while in our care, we may share your contact information or your pet's information with emergency veterinary providers or first responders as necessary to protect the health and safety of your pet.

5. Data Retention

We retain your personal information for as long as is reasonably necessary to provide our services, maintain business records, and comply with any legal obligations. If you would like us to delete your information from our records, please contact us and we will do so promptly, unless we are required by law to retain it.

6. Data Security

We take reasonable precautions to protect your personal information from unauthorized access, misuse, or disclosure. However, no method of data transmission or storage is completely secure. We cannot guarantee absolute security of any information you provide to us.

7. Cookies & Tracking

Our website may use cookies or similar tracking technologies through our hosting platform to analyze traffic and improve your browsing experience. These cookies do not collect personally identifiable information. You may disable cookies through your browser settings; however, doing so may affect your ability to use certain features of our website.

We do not use cookies to serve targeted advertisements.
