In 2025, Blue Ridge Wildlife Center (BRWC) marked 25 years of caring for and protecting native wildlife. What began as a small education effort has grown into a regional center for wildlife medicine, research, education, and professional training, grounded in the understanding that the health of wildlife, people, and the environment are deeply interconnected.

Each year, thousands of injured, ill, and orphaned animals arrive at our doors. Their stories reveal patterns of human impact, environmental change, and opportunity. Over the past quarter century, we have learned that treating individual animals is only the beginning. What truly creates change is what we learn from them, how we apply that knowledge, and how we share it with others.

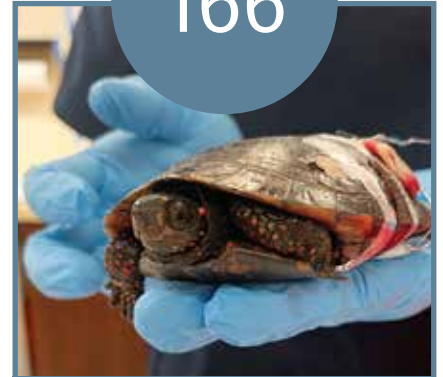

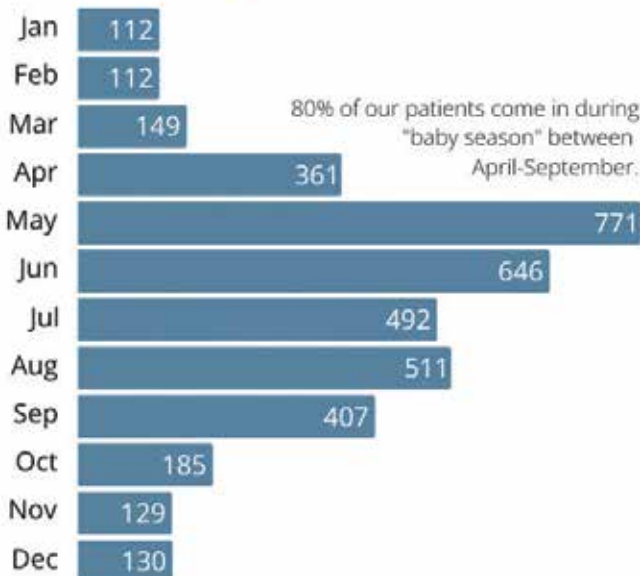

## Causes for Admission

Upon admission, our veterinary team assesses each patient, provides emergency care, and develops an individualized treatment plan. We treat more than **4,000** wildlife patients annually; almost are admitted due to human activity.

## Hit by Vehicle

Vehicles kill hundreds of millions of wild animals every year in the United States.

**660 (17%) of our patients are victims of vehicle collisions.**

Vehicle strikes often cause severe internal injuries, fractures, head trauma, and internal bleeding. Even animals that appear alert may deteriorate rapidly due to shock or internal damage. Slowing down in wildlife crossing areas, especially at dawn and dusk, saves lives. Never toss food from your car. Even items like apple cores and banana peels attract wildlife to roadsides and significantly increase the risk of vehicle collisions.

## Orphans



Most wild babies found alone are not orphaned and do not need help.

**590 (16%) of our patients were admitted as orphans.**

Many of these animals were healthy babies that could not be successfully reunited with their mothers, or were truly orphaned due to deceased parents or abandonment by parents. Many wild babies are left alone for much of the day and in many cases, intervening does more harm than good. Observing from a distance and contacting a licensed wildlife rehabilitator before intervening gives babies the best chance to stay in the wild where they belong.

## Unknown Trauma



Many of the most serious wildlife injuries happen without anyone ever seeing what caused them.

**582 (15%) of patients were admitted with unknown trauma.**

Based on injury patterns, the vast majority of these cases are likely the result of vehicle collisions or cat attacks. Slowing down on roads, keeping cats indoors, and reducing everyday hazards directly lowers the incidence of these unwitnessed but preventable injuries.

## Cat Attacks



Cats kill BILLIONS of native wildlife each year in the United States.

**483 (13%) of our patients are victims of cat attacks.**

Even small puncture wounds from a cat's teeth or claws can introduce bacteria that lead to life-threatening infections within hours. Many victims appear unharmed initially but succumb to infection without prompt treatment. By keeping your cats indoors or in enclosed outdoor spaces like catios, they will live longer, healthier lives and prevent unnecessary wildlife deaths.

## Windows Strikes



Each year, an estimated 1 billion birds die from hitting a window in the U.S. alone.

**176 (5%) of our patients are known window strikes.**

Birds don't perceive glass as a solid barrier. High-speed collisions cause brain injury, eye trauma, internal bleeding, and fractures, often resulting in death even if the bird flies away initially.

Apply external window treatments such as dot patterns, decals, or films spaced < 2 inches apart to break up reflections.

## Other Human-caused Causes of Admission (Non-intentional)



While vehicle collisions, cat attacks, and window strikes are all human-caused threats to wildlife, we use the above cause as a catch-all to describe slightly less common reasons for admission that were caused by humans who were not intentionally trying to harm the animal. This includes things like lawnmower injuries, garden netting injuries, and glue trap victims. **305 (8%) of our 2025 patients fell into this category.**

# One Health Research

In 2025 we were involved in ten research studies and one of these studies ("Eastern cottontails [*Sylvilagus floridanus*] as hosts for ticks infected with *Borrelia burgdorferi*, *Anaplasma phagocytophilum*, and Powassan virus in Virginia, USA.") was published in 2025 in the *Journal of Medical Entomology*.

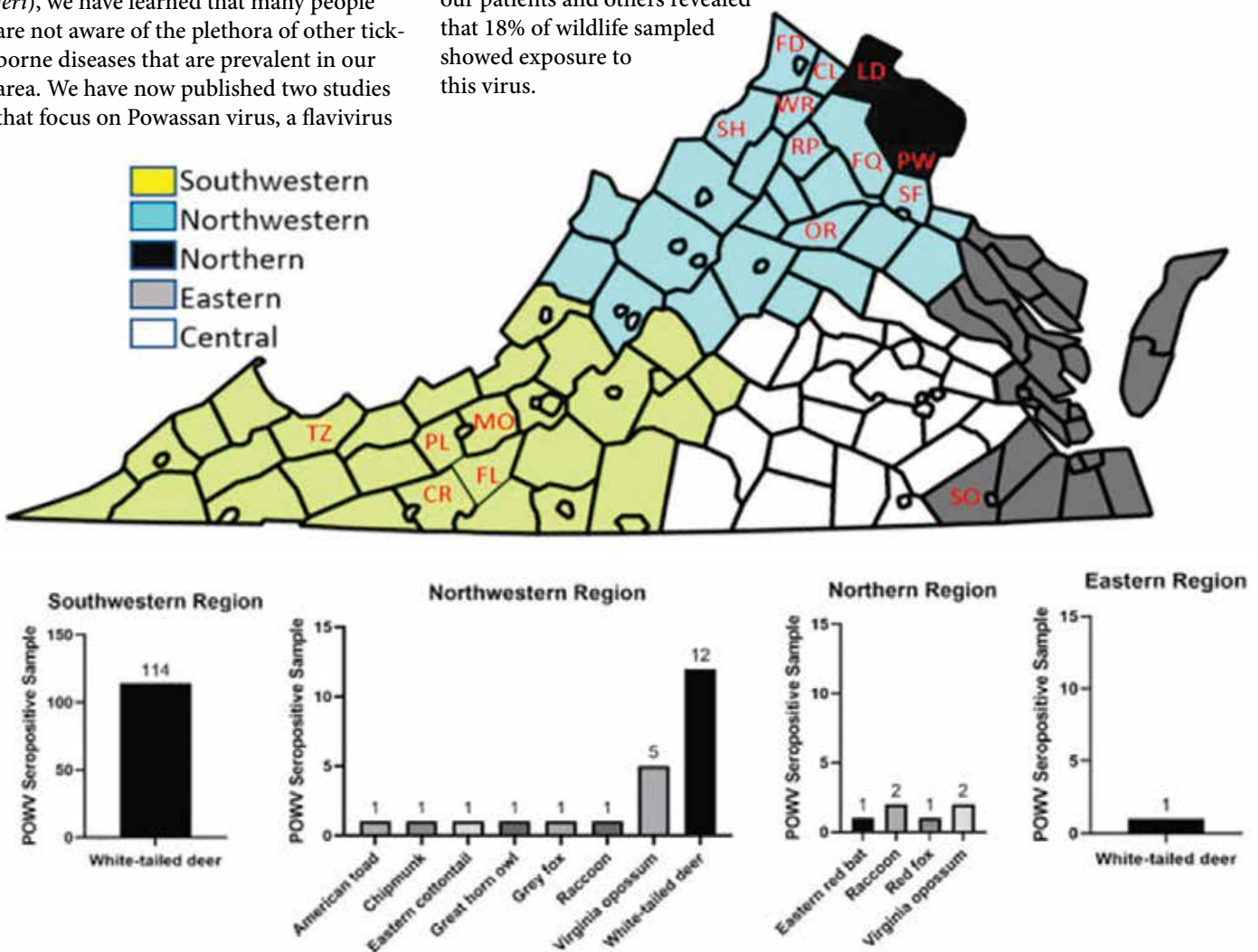

## Tick-borne disease

Tick-borne disease is a popular topic of study at BRWC given how common these diseases are in wildlife, humans, and domestic animals. While many people are aware of Lyme disease (*Borrelia burgdorferi*), we have learned that many people are not aware of the plethora of other tick-borne diseases that are prevalent in our area. We have now published two studies that focus on Powassan virus, a flavivirus

spread by ticks that can cause life-threatening neurologic disease in humans and animals. Although this disease is primarily seen in the great lakes region and the northeastern U.S., studies like ours show that it is absolutely in our area! Data from our patients and others revealed that 18% of wildlife sampled showed exposure to this virus.

## Powassan virus

Powassan virus is maintained in the environment by ticks (primarily the black-legged tick) and small mammals and spreads to humans and other species when they are bitten by an infected tick. This virus is considered rare, but reports of the disease are increasing. This is likely a combination of increase in actual prevalence and increase in awareness of the virus among physicians and veterinarians. Ultimately, studies like those conducted at BRWC provide veterinarians and physicians with information regarding the prevalence of tickborne diseases like Powassan virus and knowing that these diseases exist in our area means that doctors are more likely to order the right test and come to a diagnosis more quickly. This is one way that one health research creates optimal health outcomes for all of us. According to the Center for Disease Control and Prevention (CDC), there have been 400 cases (53 deaths) of Powassan virus infections in humans in the U.S. between 2004 and 2024. These cases primarily arise in the summer, when tick activity is the highest. Although this makes it rare, it is important to note that these cases are likely to be extremely under reported. Surveillance data like this relies on physicians not only requesting the appropriate test and making a diagnosis, but also reporting that positive result to their health department. Mild cases are also much less likely to be reported.

## How to Protect Yourself from Tick Bites

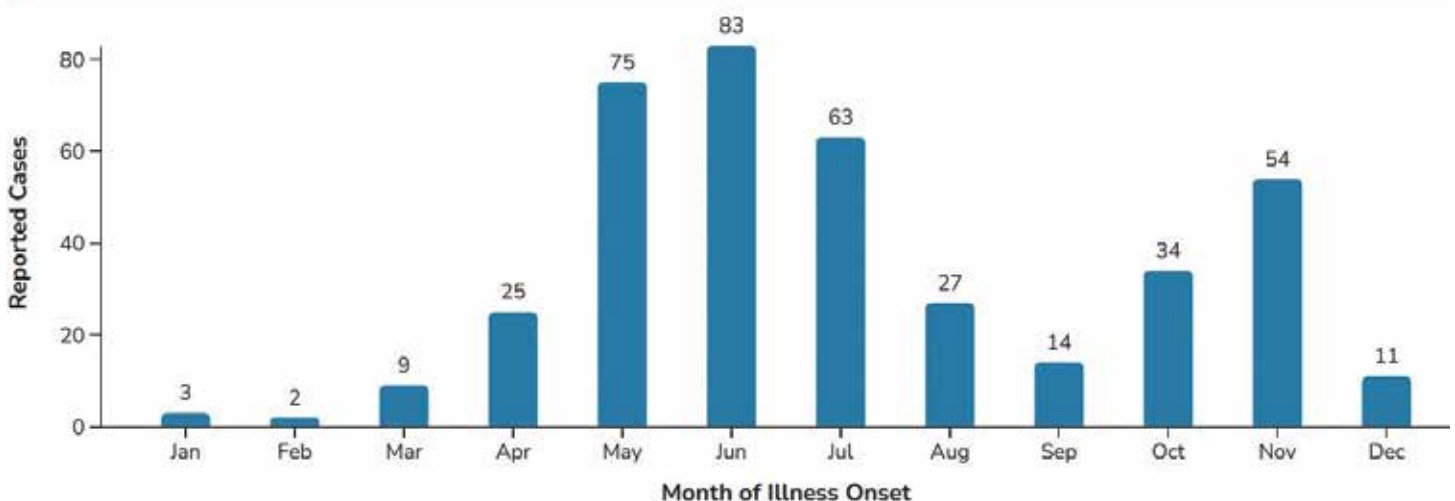
There is no vaccine for Powassan virus, but the best way to prevent tickborne infections of any kind is to protect yourself from tick bites.

- Use insect repellents (this should be applied AFTER sunscreen)
- Wear long sleeves and pants and tuck pants into your socks
- Avoid bushy and wooded areas
- Perform thorough tick checks on your gear, yourself, and pets after spending time outdoors
- Shower within two hours of coming back inside (this has been shown to reduce your risk of contracting Lyme disease and likely other tickborne diseases)
- Follow your veterinarian's guidance on tick control preventatives for your pets to keep them safe and keep ticks out of your home.

If you do get bitten by a tick, save that tick (frozen in a ziplock bag or between two pieces of clear tape) so that it can be identified if needed later. Then, follow up with your primary care provider.

## Species First!

### American Coot



This funny-footed shorebird was a species first for us after this bird was found unable to fly next to a warehouse in Woodbridge, VA. These birds are often found in marshy and water-front habitats, like nearby Occoquan National Wildlife Refuge.

### Black-billed Cuckoo



While we often get Yellow-billed Cuckoos throughout the summer, this Black-billed Cuckoo was a first for us after being a victim of a window strike—the number one reason we receive Yellow-billed Cuckoos as well.

### Least Bittern



This Least Bittern was an exciting surprise to our staff when the finder rescued the bird after a suspected window strike.

### Fisher



A first for our Center, this Fisher, a member of the weasel family rarely seen in Virginia due to their elusive nature, was brought in after a suspected vehicle strike.

## Interesting Cases

### Entrapped Raccoon

This Raccoon was brought in after the finder discovered him with his head stuck—in the hub of a car tire! Thankfully, this was a straightforward situation—the raccoon was sedated, and slowly worked out of the tire. Luckily this raccoon had no injuries from this situation, and after fully recovering from sedation and after a good meal, this guy was released back home!



## Red Fox Hit by Vehicle

This Red Fox was rescued by the finder after they witnessed the fox hit by a vehicle. Safely containing the fox in the early morning hours, they met us at our door as soon as we opened to get this fox the care she needed. On intake she was barely responsive, and was showing clear signs of internal trauma. Thankfully, she had no major wounds or fractures that required more serious intervention. After multiple days on oxygen support to help alleviate internal bleeding in her lungs, she was moved to normal hospital caging with continued pain medications and anti-inflammatories. She improved rapidly, moving to outdoor caging as her last test, and within two weeks she was successfully released!



## "Shark Fin" and "Chainsaw" Opossums



We had two unique Virginia Opossum cases come in at the tail-end of the year—one opossum we affectionately called “Shark Fin” due to the shark fin bandage we initially placed on him to keep his large

abdominal wound clean and inaccessible to him, and another we called “Chainsaw” due to her wounds being caused by a tree-trimming company chainsawing down a dead tree in which this female opossum

was denning. Thankfully, both of these opossums’ wounds were treatable, and after over two months in care, they were successfully released back home!

## Sora

This seldomly-seen wading bird was brought to us after a suspected window strike left them unable to fly and easily able to be contained in Fairfax, VA. While initially we were concerned about a soft tissue injury at one of the shoulder joints, this bird healed and recovered well with anti-inflammatories and pain medications alone. After just two weeks of care and a make-shift wetland enclosure built to help keep this bird comfortable and stress-free, this bird was released back home to an appropriate habitat!



# Professional Training

We are very excited to have launched our expanded **professional training program** in 2025. Adding much needed, well-trained, talent to the wildlife conservation workforce!



**Veterinary Fellow, Sydney Lewis, DVM** started her fellowship in July 2025 and will be with us through June of 2026.



Our first **Education Fellow, Rena Klapp**, completed her year-long training during 2025.



**Rehab Fellow, Sydnie Matda** successfully graduated from our program, and has moved on to a job working with the Carolina Raptor Center just outside of Charlotte, NC!

We also welcomed **13 Summer Rehabilitation Interns** to help us get through baby season and gain valuable experience! Combined, these interns provided over **7,000 hours**.

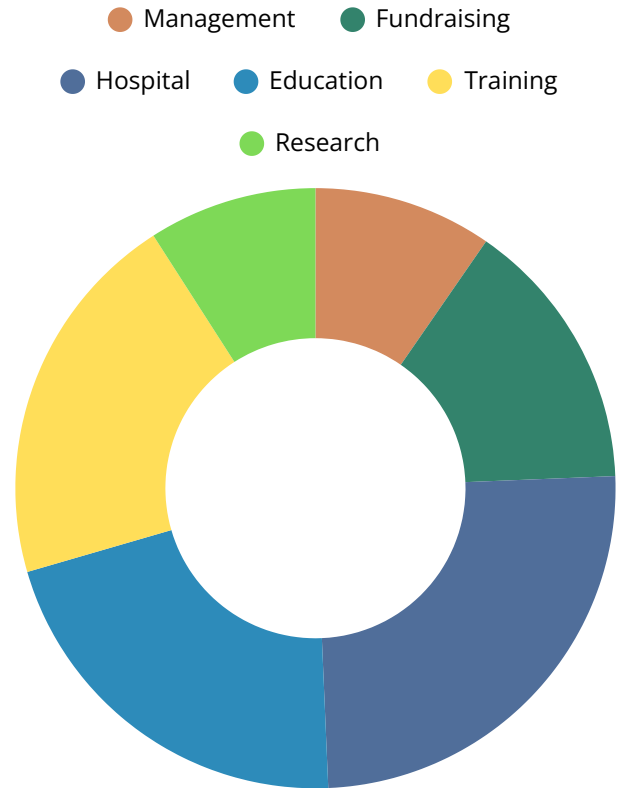
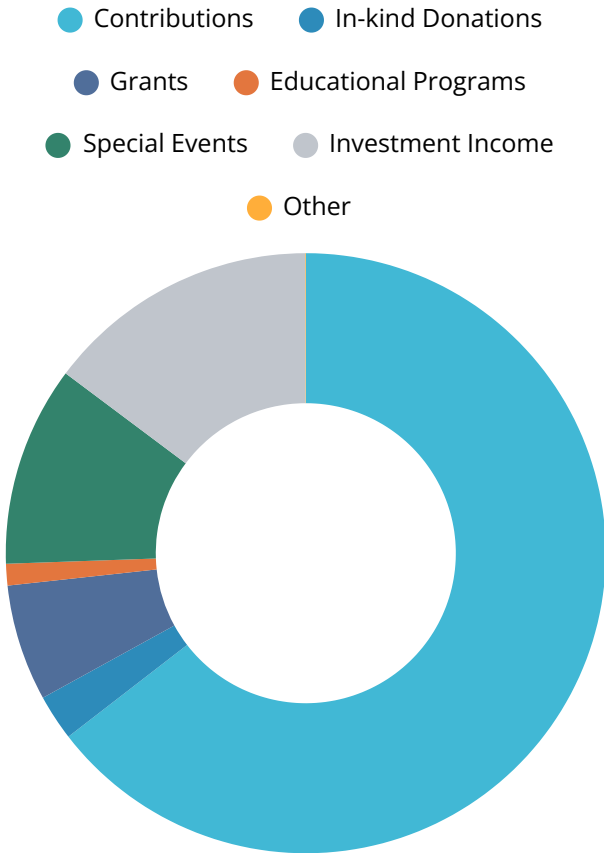
