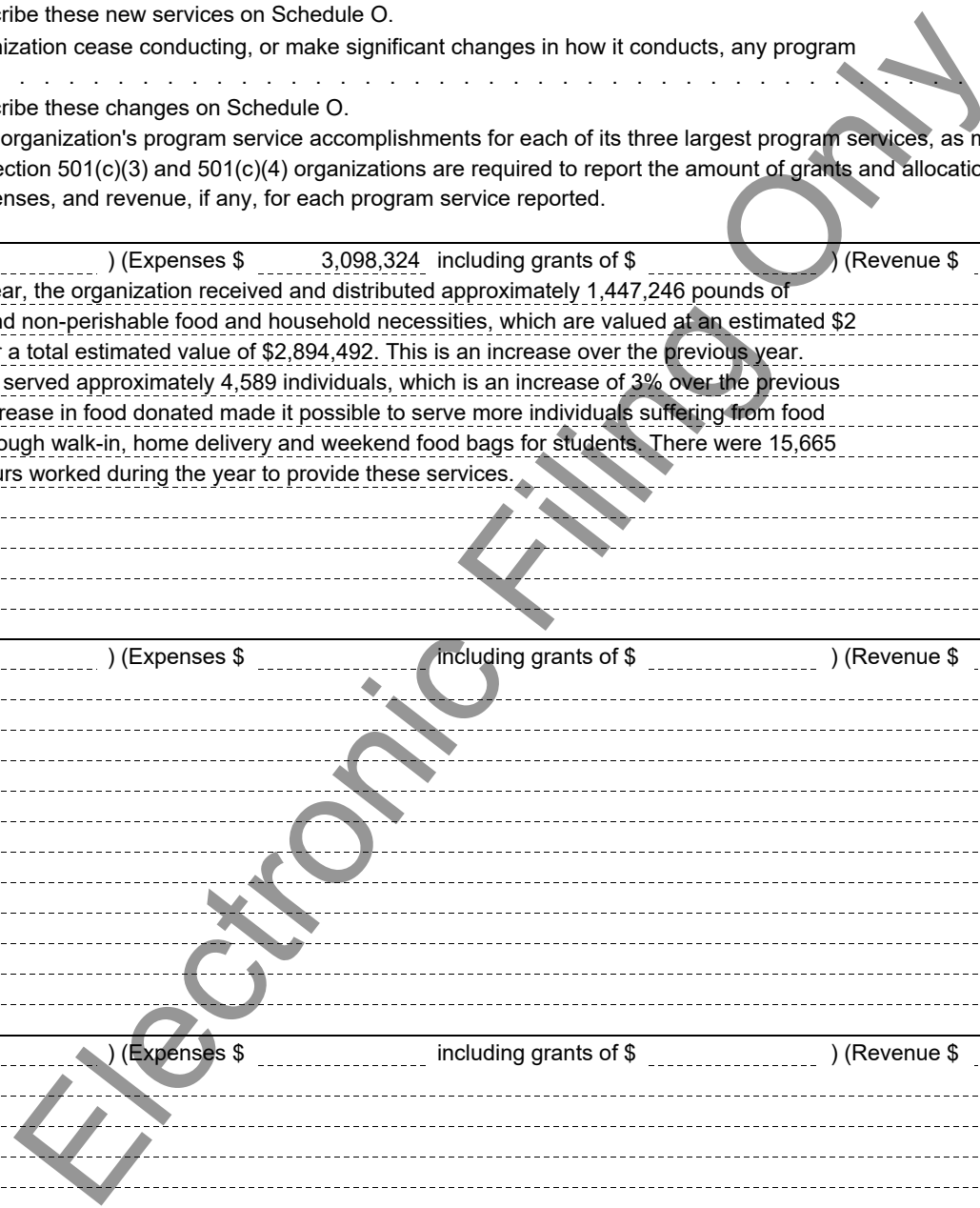

During the year, the organization received and distributed approximately 1,447,246 pounds of perishable and non-perishable food and household necessities, which are valued at an estimated \$2 per pound for a total estimated value of \$2,894,492. This is an increase over the previous year. The program served approximately 4,589 individuals, which is an increase of 3% over the previous year. The increase in food donated made it possible to serve more individuals suffering from food insecurity through walk-in, home delivery and weekend food bags for students. There were 15,665 volunteer hours worked during the year to provide these services.

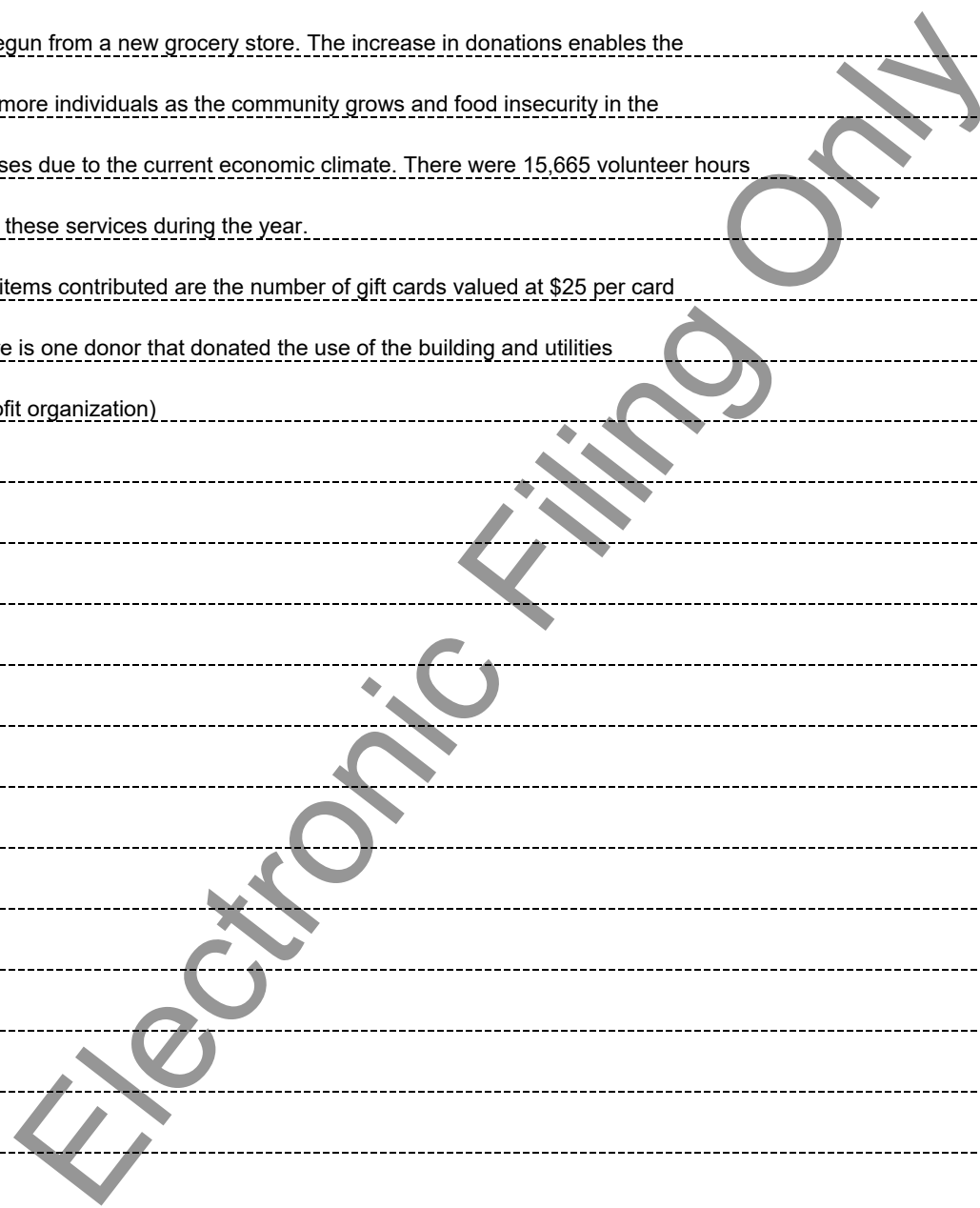
